The SCEO submitted its SC Electric Vehicle (EV) Stakeholder Report in September 2022, which included initial recommendations from SC's EV stakeholders. South Carolina Code of Laws §58-27-270(D) (2021 Act 46) further requires the SCEO to continue its EV stakeholder initiatives and report recommendations to the legislature every two years thereafter.

The Environmental Protection Agency has announced \$2 billion in funds for environmental and climate justice activities to benefit disadvantaged communities through projects that reduce pollution, increase community climate resilience, and build community capacity to address environmental and climate justice challenges. Applications are accepted on a rolling basis until November 21, 2024.

IRA Community Change Grants Program

The South Carolina Energy Office (SCEO) is pleased to announce a second round for applications for funding through the SC Energy Efficiency and Conservation Block Grant (EECBG) Competitive Subgrant Program (SC EECBG Program)!

The SC EECBG Competitive Program offers funding opportunities to support projects and programs that cut carbon emissions, improve energy efficiency, and reduce energy use in South Carolina. Updated guidance and the Application for Round 2 SC EECBG will be posted on the Energy Office website on March 18th. Applications for Round 2 EECBG are due by April 15, 2024.

SC EECBG Program

The purpose of the Low-No Program is to support the transition of the nation's transit fleet to the lowest polluting and most energy efficient transit vehicles. The Low-No Program provides funding to state and local governmental authorities for the purchase or lease of zero-emission and low-emission transit buses, including acquisition, construction, and leasing of required supporting facilities.

The purpose of the Buses and Bus Facilities Competitive Program is to assist in the financing of buses and bus facilities capital projects, including replacing, rehabilitating, purchasing or leasing buses or related equipment, and rehabilitating, purchasing, constructing or leasing bus-related facilities.

Applications are due on April 25, 2024.

Low or No Emission Grants for Buses and Bus Facilities

The Safe Streets For All program supports the development of a comprehensive safety action plan (referred to as an "Action Plan") that identifies the most significant roadway safety concerns in a community and the implementation of projects and strategies to address roadway safety issues. Action Plans are the foundation of the Safe Streets For All grant program. The first round of applications are due on April 4, 2024.
